# ON IMMORALITY IN SCIENCE AND MEDICINE: NECESSITY OF SCIENTIFIC TRIBUNALS

**INTRODUCTION:** Enormous progress by scientific-revolutions/*Thomas Kuhn* after *Copernicus* is related to *misuse of science* causing disastrous-repercussions: health-research-ecological-other problems. **Foundation of international scientific tribunals** to universities by network of continental-national can support *scientific-regulation* in form of independent link between legal&political institutions. IVR&other philosophical&juridical organizations could play leading role in this project.

### **CONCEPTION:**

#### A. Research:

- **a.** *H.von Helmholtz* (and others) defamed the also eminent scientist *J.R.Mayer* (discovery: conservation-energy-law).
- **b.** German Helmholtz-Centre-München (former GSF) deposed illegal radioactive-material (biggest European atom-scandal acc. to German Ex-Vice-Chancellor S. Gabriel), which can lead without casual analysis to water-contamination.
- **c.** Scandal about HIV-virus-discovery: *L.Montagnier* received *Nobel-price*, *but not R.Gallo*, because of immorality!
- **d.** Austrian&German universities destructed international-laboratories by totalitarian methods. *Proposal:* Transformation of GSF into German Society for Future Anthropology (GSF-A) as international research centre incl. leading role in scientific programmes&administration by IVR/FISP/German-organizations. Foundation of branches to universities, e.g. Univ. Lucerne, Munich, Innsbruck, etc.
- **B. Education:** *German medical-faculty* declined medical dissertation (6-positive/2-negative-referees).

Proposal: Scientific tribunals which consider conflicts about academic titles.

# **C. Technology**-*Chronobiology*&*photobiology*:

- **a.** Summer-winter-time (difference) leads to permanent *patho-physiological-reactions* supporting diseases.
- b. New energy saving lamps (pathogenic light-discontinuity-spectrum&possible mercury-

intoxication) induce pathophysiological reactions.

*Proposal:* Int. scientific tribunals which give recommendations for UNO/EU, etc. about conflicts conc. summer-winter-time/light problems.

**D. Health-Medicine.** Monodimensional (ultra specialization), immoral&economized medicine damages patients&state, e.g. surgical-leg-therapy: patient was pharmacological&surgically treated for 10 days: costs about 15000 Dollars. The same disease after 1-year false treatment led to invalid state (patient cannot go): costs over 0.5million Dollars for 1-year therapy! *Proposal:* Scientific tribunals (not int.) which support projects about central medical-problems giving concrete-proposals for WHO/CIOMS/nat. health inst. (ministries, etc.).

**CONCLUSION:** *International* **scientific tribunals** via network of national-continental-int. ones, supported by IVR&other organizations, *giving* practical scientific-political recommendations, counteracting impossible situations (A.-D.) & supporting **UNO-Agenda21** for better education-health-ecology-economy.
